As was seen during the COVID time period, having strong partners is critical. Now that COVID supply chain disruptions have largely passed – other risks remain. Some major risks are international freight operators manipulating freight rates and service disruptions & various global conflicts. There are heightened chances of disruptions in the APAC region with constant increasing tensions around the South China Sea area where one third of global trade large passes through. There's extreme volatility in international freight contract and spot rate pricing that require a clear strategy to manage.

Developing supply chain resilience is the logistics theme of the decade and a principle that underpins Access ZG's range of services.

Connect with suitable freight & logistics providers. Your business provides its supply chain & freight needs and concerns to Access ZG. This is then matched, in a similar way to the mortgage or insurance broker business model, with 'suitable providers'. You'll be given advice regarding exisiting provider/s in your supply chain and will have the option of maintaining logistics providers for elements that are viewed as important to remain. 'Suitable providers' are chosen based on their respective strengths and your preference regarding service, pricing, speed to act. 'Suitable providers' have services closely matched to your needs across ocean, air, rail, trucking, warehousing, customs & software. Get direct access to suit of overseas and local logistics providers & staff. Able to mix and match. Stay with or change providers for different aspects of the supply chain. Eg different local and overseas providers.

Overseas APAC providers can be the hardest part to navigate. Drop the language, cultural barriers via accessing a network of contacts and staff on the ground overseas that literally and metaphorically 'speak' the language of your import / export market. Issues with suppliers / buyers / overseas freight providers have better outcomes when dealing with a single point of contact with resources on the ground overseas, acting on your behalf.




Logistics offices here have limited information about what's really going on overseas regarding specific issues relevant to you. Get deep overseas source insights and knowledge via Access ZG's internal & close contacts overseas. In Australia / New Zealand, different providers also have varying strengths and ways of operating here & interacting with overseas providers.



# Fourth party logistics (4PL)

With a 4PL, the customer doesn't have to worry about managing relationships with multiple vendors or making decisions on logistics. There is no need for a 100% internal / a full in-house logistics department or the need to build logistics capabilities, freeing up more time for customers to focus on their business.

First party logistics (1PL) are shippers/ manufacturers / wholesalers/ retailers / importers/ exporters Second party logistics (2PL) are the direct owners of aircraft, vessels, trucks, rail etc Third party logistics (3PL) are freight forwarding shipment services

Fourth party logistics (4PL) services may include a single partner that advises and manages the supply chain by overseeing the combination of warehouses, shipping companies, freight and agents etc., impartial advice, data flow, procurement & inventory management....
